INTRODUCTION, Cont'd

What is REX System?

- The REX system = new system of certification of origin in the GSP scheme of the European Union which became applicable as from 1st January,2017
- REX = self-certification system by exporters, replacing certification of origin by Customs authorities.
- Exporters will directly provide their customers with <u>statements on origin.</u>



INTRODUCTION, Cont'd

Statement of origin

The exporter ... (Number of Registered Exporter) of the products covered by this document declares that, except where otherwise clearly indicated, these products are of ... preferential origin according to rules of origin of the Generalised System of Preferences of the European Union and that the origin criterion met is



INTRODUCTION, Cont'd

Key elements of REX:



- 1. All exporters to the European Union need to be registered by Competent Authority(ZRA)
- 2. Exporter applies(electronically/manually) and submits,
- 3. At registration a unique REX number assigned by ZRA
- 4. Use REX number on statements of origin to be made on any commercial document



Key issues to note during the implementation of the REX system

REX START Date

Implement REX from 1st January,2017

IMPLEMENT REX Registration will be undertaken from 1st January, 2017 to 31st December, 2017

FORM A IN Transition Period During TRANSITION both certificates of origin Form A and Statements on Origin will be applied simultaneously until all eligible exports are registered.



Key issues to note during the implementation of the REX system

ONE TIME REGISTRATION

Exporters registered **ONCE** in REX.

BEYOND TRANSITION PERIOD

REX system will apply <u>NO</u> Certification on FORM A

BC-CA (ZRA) CUSTOMS B C-CA(Customs) continues to undertake compliance checks and verifications of origin as deemed necessary.



Expected Benefits

FREED TIME

CA in BC will have free time to perform more controls on their exporters and the declarations on origin they will make out.

REDUCED CONTACT WITH CA No need for exporters to contact their CA for each and every export under GSP: currently CA issue certificates of origin Form A for all exports.

IMPROVED EFFICIENCY Improved efficiency in the certification of origin process by eliminating the manual Form A(EUR1)

Exporters pre-application

Exporter fills application manually or online: https://customs.ec.europa.eu/rex-pa-ui/

If online application, exporter validates information & saves

Exporter prints form, <u>SIGNS</u> and sends to CA for registration

CA-LU inputs manually or uploads electronically pre-application form, REGISTERS and generates REX#



REX Application Form (AREX Form)

- Indicative description of goods which qualify for preferential treatment, including indicative list of Harmonised System headings (or chapters where goods traded fall within more than twenty Harmonised System headings).
- 5503 Synthetic staple fibres, not carded, combed or otherwise processed for spinning
- 5504 Artificial staple fibres, not carded, combed or otherwise processed for spinning
- 5. Undertakings to be given by an exporter

The undersigned hereby:

- declares that the above details are correct;
- certifies that no previous registration has been revoked; conversely, certifies that the situation which led to any such revocation has been remedied;
- undertakes to make out statements on origin only for goods which qualify for preferential treatment and comply with the origin rules specified for those goods in the Generalised System of Preferences;
- undertakes to maintain appropriate commercial accounting records for production / supply of goods
 qualifying for preferential treatment and to keep them for at least three years from the end of the
 calendar year in which the statement on origin was made out;
- undertakes to immediately notify the competent authority of changes as they arise to his registration data since acquiring the number of registered exporter;
- undertakes to cooperate with the competent authority;
- undertakes to accept any checks on the accuracy of his statements on origin, including verification of
 accounting records and visits to his premises by the European Commission or Member States'
 authorities, as well as the authorities of Norway, Switzerland and Turkey (applicable only to exporters
 in beneficiary countries):
- undertakes to request his removal from the system, should he no longer meet the conditions for exporting any goods under the scheme;
- undertakes to request his removal from the system, should he no longer intend to export such goods





After the REX authorization is done (i.e. AREX form is signed and stamped), the Registered Exporter must be notified for his/her valid registration.

REX Number format

- **□ REX** number:
 - > Important notes:
 - ✓ Only numbers 0..9 and capital letters A..Z must be used;
 - ✓ The REX number is manually filled-in by the user, not automatically generated.
 - **Examples of REX Numbers:**
 - ✓ ZMREX1003341634 for a Zambia exporter 1 (country code: ZM).
 - ✓ ZMREX1001433416 for a Zambia exporter 2 (country code: ZM)
 - ✓ ZMREX1003528119 for a Zambia exporter 3 (country code: ZM)



TPIN Number format in REX

- ☐ TPIN number:
 - > To be used in the Beneficiary countries
 - ➤ The TIN number has up to 17 characters(ZM, 10; complaint)
 - ➤ TIN number should start with the ISO 2-letter country code + up to 15 characters
 - **Example: ZM1003528119 (where ZM= Zambia)**



Edit of a REX authorisation

- ☐ A registered exporter has the obligation to communicate all changes related to the data registered in the REX system;
- ☐ In each section of the REX Authorisation the non editable fields are presented as grey area and the editable fields as white area;
- ☐ The following data may be modified:
 - Exporter's Information: Name, Address, Email Address, Fax and Phone Number;
 - **Exporter's Contact Person Details;**
 - > Exporter's Activities;
 - **Description of Goods.**



Revocation Reasons

Revocations can take place in 2 ways:

- **at the request of the exporter** (or re-consignors in MS):
 - **because he no longer meets the conditions for exporting any goods under the GSP scheme;**
 - > or no longer intends to export under the GSP scheme;
 - > the company does not exist anymore;
- on the initiative of the BC Competent Authority
- > the company has failed to comply with its obligations;
- the company has committed fraud;
- the company does not exist anymore.
- on the initiative of the EU/CH/NO:
- ➤ All REX numbers of a given country will be automatically revoked when the country is removed from the GSP scheme it is part of.



Annulment of a Revoked REX Authorisation

- **☐** Annulment of Revocation can happen only:
 - ➢ if a revoked exporter wins an appeal against his revocation;
 or
 - > if the revocation was done by mistake.
- ☐ In other situations, the exporter has to re-apply to become a registered exporter and will receive a new REX Number.
- □ Once a REX Number is revoked, the same number cannot be reassigned(i.e to another exporter).



Publication of the registered exporter data (1/3)

- ☐ The data of the REX System is published at:

 http://ec.europa.eu/taxation customs/dds2/eos/rex home.jsp?Lang=en
- Economic Operators will be able to verify the validity of the registrations of the registered exporters who submit those statements on origin (it is not part of the REX Application);
- ☐ In the application form, a registered exporter may give consent to publish his data on the public website;
- □ Otherwise, only a subset of the registered data will be published to allow operators to verify the validity of a REX number.



Publication of the registered exporter data (2/3)

- ☐ If the exporter gives his consent (box 6 of Application form signed), the following data is made public on Internet:
 - > TPIN number and REX number of the registered exporter
 - ➤ Name of the registered exporter
 - > Address of the place where the registered exporter is established
 - Contact details of the registered exporter
 - ➤ Indicative description of the goods which qualify for preferential treatment
 - Date from which the registration is valid
 - > Date of the revocation (if applicable)



Publication of the registered exporters data (3/3)

- ☐ If the exporter does not give his consent (box 6 of Application form not signed), the following data is made public on Internet:
 - > TPIN number of the registered exporter;
 - **REX Number and its Status;**
 - > Date from which the registration is valid;
 - > Date of the revocation (where applicable).



Key points to note REX registration

Online Pre-Application highly recommended

Once registered in REX only Statement on Origin will be form of certification of origin to EU market

Statement on Origin with REX number made on commercial documents

TPIN for REX registration ALWAYS begin with ISO 2-letter country-ZM; e.g ZM1003528119

During the transition period(1-Jan2017 to 31-Dec,2017), FORM A for Exporters not yet registered will apply.

From 1st January,2018 on onward certification of origin for EU GSP <u>ONLY</u> be by Statements on Origin
